# Kvitova, Halep, Pliskova in quarters

**Dubai:** Former winners **Petra Kvitova** and **Simona Halep** battled through brisk desert winds to advance into the quarter-finals of the Dubai Championships on Wednesday.

Second seed Kvitova outlasted American qualifier Jennifer Brady 7-5, 6-3.

Crowd favourite and third seed Halep coped with the gusty conditions the Aviation Club as she beat Lesia Tsurenko 6-3, 7-5, breaking seven times.

Ukraine's Tsurenko managed just a single point over the last three games as former number one Halep demonstrated her superiority by taking a 7-0 lead in their head-to-head record.

Fourth-seeded Karolina Pliskova was tested by Alison Riske, with the Czech taking more than two hours to produce a 7-6 (7/3), 7-6 (7/5) victory. Fifth seed Angelique Kerber, a semi-finalist on her last two appearances here, lost to Hsieh Su-Wei 5-7, 6-4, 6-0.

World No. 1 Naomi Osaka was beaten in her opening match on Tuesday, losing to France's Kristina Mladenovic 6-3, 6-3 on her return to competitive action after winning last month's Australian Open. Osaka, who parted ways with coach Sascha Bajin last week following her victory in Melbourne, struggled with her service game, winning 48 per cent of her first serve points and making 25 unforced errors as she folded in just over an hour. Meanwhile, Kvitova, who won the Dubai trophy in 2013, had not played on the WTA Tour since reaching the St Petersburg quarter-finals a fortnight ago.

"When I came here, I didn't really have many days of practice, to be honest," the two-time Wimbledon winner said. "I had something different to do in my life. I wasn't really that prepared for this tournament."

**Djere stuns Thiem:** Top seed Dominic Thiem was knocked out the Rio Open in the first round on Tuesday, going down 6-3, 6-3 to Laslo Djere, a result that gave the unheralded Serbian his first victory over a top 10 player in his career. The world ranked No. 90 broke Thiem's serve five times. Thiem served five double faults. AGENCIES

**New Delhi:** India's boxing chief Ajay Singh has been elected as president of the Foundation Board for Better Boxing of the world governing body of the sport, AIBA. Foundation for Better Boxing was constituted by the AIBA in the last meeting of their Executive Committee to address future development of the sport globally.

Boxing Federation of India chief Singh was elected to the post on Tuesday and he will have a tenure of four years.

"With the aim of the foundation being to improve and spread the sport globally, Singh's vision will help boxing move forward in the right direction," said a release. Tom Virgets has been elected as the Secretary. "Our job will be to work in the best interest of promoting boxing and protecting interests of boxers globally," he said.

**New Delhi:** The Badminton Association of India (BAI) on Wednesday announced 20-member junior India squad for the six-day Dutch Junior International, starting on February 27, and the four-day German Junior 2019 starting on March 7.

Manipur's Maisnam Meiraba Luwang will be leading the boys' singles challenge by virtue of the 1192 points that he amassed following his title wins at the All-India Junior Ranking Badminton Tournaments in Vijayawada and Bengaluru. The girls' team will be spearheaded by the 2017 U-15 Asian Junior Championships gold medalist Samiya Imad Farooqui.
